- Step 2 SSBT or ASG will issue a Letter of Offer/Student Agreement for you to sign and return.
- Step 3 Arrange your payment by bank transfer or credit card (Visa or MasterCard) then send your payment receipt to SSBT or ASG.
- Step 4 If you are an international student applying for a Student Visa, SSBT or ASG will issue your Confirmation of Enrolment (eCoE). Other applicants will be sent a statement/receipt as confirmation of their enrolment.
- Step 5 Pre-arrival and orientation information will be sent to you prior to your course commencement.
